



Rates of War Pensions and allowances 2011 - 2012

About this leaflet

These rates start from the week beginning 11 April 2011. We use Army ranks to show the rates, but they are the same for equivalent ranks in the Royal Navy and Royal Air Force.

The War Pensions Scheme is run by Service Personnel and Veterans Agency, an Executive Agency of the Ministry of Defence. This leaflet gives you general guidance, but it is not a definitive (full) statement of the law. Please remember that the law may change from time to time. This may affect your rights and responsibilities, including whether you are likely to get a War Pension.

Middle finger - for the loss of:

More than 2 phalanges, including loss of whole finger £6569

More than 1 phalanx, but not more than 2 phalanges £5055

One phalanx or part of one £4042

Guillotine amputation of tip without loss of bone £2527

Ring or little finger - for the loss of:

More than 2 phalanges, including loss of whole finger £4042

More than 1 phalanx, but not more than 2 phalanges £3543

One phalanx or part of one £3026

Guillotine amputation of tip without loss of bone £1515

Toes

In this table, a toe may be lost **through the joint** (the metatarso-phalangeal joint), or only **part of the toe** may be lost but with some loss of bone.
